This change is ordered forthwith pending final revision to Los Angeles County Court Rules, Volume IIIE – Superior Court, applicable to Rule 2.3(a)(B), Optional Filing, Re Dissolution of marriage; Domestic violence restraining order; Family law miscellaneous complaints or petitions; Foreign custody (family law); Foreign support (family law); Legal separation (family law); and Voiding of marriage. Until such final revision is adopted by the executive committee, the District boundaries as shown in
