Exemptions: Please note that community service performed for a public entity, including Cal-Trans; programs other than the performance of community service (i.e. Hospital and Morgue programs, also referred to as HAM); community service or programs arranged through the Los Angeles County Probation Department for juveniles; or as the Supervising Judge of the Criminal Division may order for good cause may, but is not required to be, arranged through a CSRA on this list.
