1 **Clerk's Action:**

2 After receipt of the order and original resolution signed by the bench officer, the clerk must:

- 3 1. Issue a minute order in conformity with the court's order;
- 4 2. Make a copy of the *original resolution signed by the Judge* for the file and place the copy in the file;
- 5 3. Mail the minute order and the *original resolution signed by the Judge* to the humane society which filed the application;
- 6 4. Mail a copy of Judge Espinoza's letter to the newly appointed/reappointed humane officer;
- 7 5. Mail notice of the court's order (*without* mailing the resolution) to the City Attorney's Office, Office of the District Attorney and the Sheriff's Office. The addresses of these entities should be indicated on the proof of service attached to the application.
