## COURT OFFERS MCLE BENCH CONDUCT AND DEMEANOR TRAINING FOR TEMPORARY JUDGES

The Los Angeles Superior Court Temporary Judge Program is offering training for temporary judges pursuant to CRC Rule 2.812, et seq. Attorneys who have been a member of the State Bar of California for 10 years are eligible to apply as a temporary judge. This training is mandatory prior to appointment as a temporary judge. CRC 2.812(b). The Court is the program sponsor and is approved as a provider of Minimum Continuing Legal Education credit by the State Bar of California (Provider No. 485). Participants will receive three hours of in-person Bench Conduct and Demeanor training.

Bench Conduct and Demeanor: Oct. 24, 2014. MCLE CREDIT: Provider No. 485. The Los Angeles Superior Court has been approved as a continuing legal education provider of Minimum Continuing Legal Education credit by the State Bar of California. This program will qualify for Minimum Continuing Legal Education credit by the State Bar of California in the amount of three hours of participatory credit: 1.0 hour will apply to elimination of bias in the legal profession credit, 1.0 hour will apply to legal ethics credit, and 1.0 hour will apply to general credit (of which zero hours will apply to prevention, detection and treatment of substance abuse/mental illness that impairs professional competence), as appropriate to the content of the program.
