LOS PADRINOS JUVENILE COURTHOUSE DELINQUENCY CASE REASSIGNMENT

As of May 1, 2019, all existing juvenile delinquency cases filed at the Los Padrinos Juvenile Courthouse with continuance dates set *after* Sept. 3, 2019, are ordered reassigned to the Eastlake Juvenile Courthouse or the Compton Courthouse, depending on the previously assigned courtroom/judicial officer. Individual transfer notices for each reassigned case will be delivered or sent to all interested parties.

Effective Sept. 3, 2019, all juvenile delinquency petitions previously heard in Department 250 of the Los Padrinos Juvenile Courthouse will be heard at the Eastlake Juvenile Courthouse, Department 204. The Eastlake Juvenile Courthouse is located at 1601 Eastlake Ave., Los Angeles 90033.

Effective Sept. 3, 2019, all juvenile delinquency petitions previously heard in Department 251 of the Los Padrinos Juvenile Courthouse will be heard at the Compton Courthouse, Department 262. The Compton Courthouse is located at 200 W. Compton Blvd., Compton 90220.

LASC/LOS PADRINOS JUVENILE COURT DELINQUENCY CASE REASSIGNMENT -2-

Non-detained petitions with a citation to appear on or after Sept. 3, 2019, shall be cited to and filed at the court location as outlined in the chart below.

Effective Sept. 3, 2019, all *new* petitions which previously would have been filed at the Los Padrinos Juvenile Courthouse will be filed as reflected in the chart below:
