## COURT OFFERS TRAINING TO TEMPORARY JUDGES FOR NEW UNLAWFUL DETAINER MANDATORY SETTLEMENT CONFERENCE PROGRAM

The Court is launching a pilot program to provide Mandatory Settlement Conferences on the day of trial in Unlawful Detainer actions heard at the Stanley Mosk Courthouse. Training will be provided for current and new Temporary Judges interested in participating in the program.

<b>TIME:</b>	Registration and lunch (provided by the Court) begin at noon. Orientation and training: 12:45 p.m. to 4:30 p.m.
<b>PARKING:</b>	Information will be provided with enrollment confirmation

An attorney interested in becoming a **new** Temporary Judge and participating in this program must meet the following requirements:

1. Be a member in good standing of the State Bar of California for 10 years;
2. Submit an application to serve as a Temporary Judge and an application to serve as a Temporary Judge for the UD MSC program by **August 16, 2019**;
3. Participate in the in-person Bench Conduct and Demeanor Training on **September 10, 2019**;
4. Participate in the in-person UD MSC training on **October 21, 2019**;
5. Complete three hours of online training in Judicial Ethics for Temporary Judges; and
6. Complete the Judicial Council of California online Unlawful Detainer training course offered for Temporary Judges.

A **current** Temporary Judge interested in participating in this program must meet the following requirements:

1. Submit an application to serve as a Temporary Judge for the UD MSC program by **August 16, 2019**;
2. Participate in the in-person UD MSC training on **October 21, 2019**; and
3. Complete the Judicial Council of California online Unlawful Detainer training course offered for Temporary Judges.
