CHILD SUPPORT (AB 1058) COURT OPERATIONS TO RELOCATE NEXT MONTH FROM CENTRAL CIVIL WEST COURTHOUSE TO STANLEY MOSK COURTHOUSE

Effective Monday, April 19, 2021, the Court's AB 1058 Child Support Commissioner Program courtrooms, Clerk's Office and the Family Law Facilitator Office will move from Central Civil West Courthouse (CCW), located at 600 S. Commonwealth Ave., Los Angeles, to the Stanley Mosk Courthouse (SMC), located at 111 N. Hill St., Los Angeles. All court-related functions at CCW will cease on April 16.

Cases with hearing dates on or after April 19 will be heard by the existing court commissioner at SMC on the same date and time currently scheduled, unless otherwise noticed. Notices will be mailed to parties with upcoming hearing dates. A flyer will be attached to new filings notifying the parties of the changed location. Clerk's Office – AB 1058 Child Support Commissioner Program

The Clerk's Office – AB 1058 Child Support Commissioner Program (Clerk's Office) is moving from Room 314 at CCW to Room 425B (4th floor) at SMC. Family Law Facilitator Office

The Family Law Facilitator Office is moving from Room 1602 at CCW to Room 426 (4th floor) at SMC. **On-site, in-person services will continue to be available by appointment only.** To schedule a telephone, Webex, or on-site appointment, call the Self-Help Center at (213) 830-0845.

Stanley Mosk Courthouse

Business hours for SMC are 8 a.m. to 4:30 p.m., Monday through Friday, except Court holidays. There is no public parking at the courthouse; however, pay lots are available nearby and throughout the downtown area. The DASH bus services the Downtown/Civic Center area and the Metro Rail's Civic Center/Grand Park station exit is nearby.

IMPORTANT: Appointments are required to visit the Clerk's Office or the Family Law Facilitator Office. Make sure to bring your on-site appointment or hearing information with you to access the courthouse for in-person services. In accordance with the [General Order No. 2020-GEN-025-00](#), access to the courthouse is restricted and all persons are required to wear a face mask over their nose and mouth while in a courthouse. Persons whose disabilities preclude them from wearing face coverings (see [California Department of Public Health Guidance Concerning the Use of Face Coverings issued on June 18, 2020](#)) are urged to seek an accommodation under Rule 1.100 of the California Rules of Court in advance of their court appearance or appointment.
