ADMINISTRATIVE ORDER OF THE  
 PRESIDING JUDGE RE COVID-19  
 PANDEMIC

**GENERAL ORDER**

Public health authorities recently lifted COVID-19 restrictions in response to the decreased number of coronavirus cases and the increasing number of residents who are vaccinated. Today, the Occupational Health and Safety Standards Board voted to approve its Proposed Revisions to the COVID-19 Prevention Emergency Temporary Standards that, among other things, effectively remove social distancing mandates in indoor workspaces and allows employers to permit fully vaccinated employees not to wear masks.

While the Superior Court of Los Angeles County (LASC or Court) determines how to operate safely at pre-pandemic levels, it will continue to limit the number of persons who enter its courthouses and enforce other physical distancing measures.

**THE COURT HEREBY FINDS, AND ORDERS AS FOLLOWS:**

**1. Courthouse Access and Remote Appearances:**

- a. In the interest of safeguarding the well-being of court users and enforcing social distancing, persons seeking services from the Clerk's Office, court support services, and/or the Self-Help Centers must have a prescheduled appointment. For telephone or video assistance, or [to schedule an appointment](#), the telephone number for each courthouse is listed at the courthouse entry and posted on the Court's website, [www.lacourt.org](http://www.lacourt.org).

- 1           b. Access to LASC proceedings is governed by [General Order No. 2020-GEN-025-00](#)  
2           issued on November 23, 2020.

3           **2. Face Coverings and Social Distancing:**

- 4           a. In accordance with [Amended General Order No. 2021-GEN-009-02](#) and consistent  
5           with the California Department of Public Health [Guidance Concerning the Use of](#)  
6           [Face Coverings](#) issued on June 15, 2021 (Guidance), all persons – regardless of  
7           vaccination status – are required to wear face coverings over their nose and mouth  
8           while in a courthouse. Persons whose disabilities preclude them from wearing face  
9           coverings compliant with the Guidance, are urged to seek an accommodation under  
10           [Rule 1.100](#) of the California Rules of Court in advance of their court appearance or  
11           appointment.  
12           b. The Court will continue to enforce social distancing in its courthouses while it  
13           evaluates its social distancing protocols. The Court anticipates aligning its protocols  
14           to the [Emergency Temporary Standards to Protect Workers from COVID-19](#) adopted  
15           by the Occupational Safety and Health Standards Board (OSHSB) on June 17, 2021,  
16           shortly. It will revise its General Orders as appropriate to reflect any changes.

17           **3. Judicial Emergency Order Continuances:**

- 18           a. Juvenile Dependency  
19           i. The Court extends the time periods provided in section 313 of the Welfare and  
20           Institutions Code within which a minor taken into custody pending dependency  
21           proceedings must be released from custody to not more than seven (7) days,  
22           applicable only to minors for whom the statutory deadline would otherwise expire  
23           from **June 19, 2021, to July 16, 2021**, inclusive.  
24           ii. The Court extends the time periods provided in section 315 of the Welfare and  
25           Institutions Code within which a minor taken into custody pending dependency  
26           proceedings must be given a detention hearing to not more than seven (7) days,  
27           applicable only to minors for whom the statutory deadline would otherwise expire  
28           from **June 19, 2021, to July 16, 2021**, inclusive.

1           b. Criminal

- 2           i. Pursuant to the authority granted by the [March 30, 2020 Statewide Emergency](#)  
3           Order issued by the Honorable Tani G. Cantil-Sakauye, Chief Justice of California  
4           and Chair of the Judicial Council which the Court implemented in its [General](#)  
5           Order No. 2020-GEN-007-00 issued on April 2, 2020, and until further notice, the  
6           Court extends the time provided by section 859b of the Penal Code for the  
7           holding of a preliminary examination and the defendant's right to release from 10  
8           court days to not more than 30 court days.
- 9           ii. The Court extends the time period provided in section 1382 of the Penal Code for  
10          the holding of a criminal trial by not more than 30 days, applicable only to cases  
11          in which the original or previously extended statutory deadline otherwise would  
12          expire from **June 19, 2021, to July 16, 2021**, inclusive.
- 13          iii. The Court extends by 90 calendar days post-conviction progress reports set on  
14          **June 19, 2021, to July 16, 2021**, inclusive.
- 15          iv. The Court extends by 90 calendar days, unless statutorily required to be held sooner  
16          and the defendant does not consent to a continuance, out-of-custody misdemeanor  
17          pretrial hearings set on **June 19, 2021, to July 16, 2021**, inclusive.

19           **THIS ORDER IS EFFECTIVE IMMEDIATELY AND WILL REMAIN IN EFFECT**  
20           **UNTIL FURTHER NOTICE, OR UNTIL ITS PROVISIONS EXPIRE BY THEIR TERMS,**  
21           **ARE RESCINDED, AMENDED, OR ARE SUPERSEDED BY SUBSEQUENT ORDERS.**

22           **THIS ORDER MAY BE AMENDED AS CIRCUMSTANCES REQUIRE.**

23           **GOOD CAUSE APPEARING THEREFOR, IT IS SO ORDERED.**
