Prior to her appointment to the bench, Judge Kwan supervised the Consumer Protection Section and Dispute Resolution Program at the Los Angeles City Attorney's Office. She tried over 60 jury and non-jury trials and handled many highprofile consumer fraud cases.

During her judicial career, Judge Kwan had various assignments and responsibilities. She has presided over hundreds of felonies and civil jury trials during her 27-year judicial career. Currently, she sits in a Long Cause Civil Trial Court in the Stanley Mosk Courthouse. Prior to her current assignment, Judge Kwan sat in an Independent Calendar Court for 14 years, where she presided over the following types of cases: business and other commercial matters; real estate disputes; construction defects; insurance bad faith; trade secret violations; personal injury matters including wrongful death, TBI, sexual abuse, asbestos and products liability; employment matters which included class actions, PAGA actions, FEHA, and wage and hour violations; and many others. She serves as co-chair of the Diversity Inclusion Working Group and is a part of the production team that put together LASC's Trial Advocacy Skills Program.
