Per the requirements of AB685, please note that each row represents one individual who has tested positive for COVID-19 and was on Court premises during the infectious period. Any individual who was not present AT THE WORK SITE during the infectious period or was off work DURING THE INFECTIOUS PERIOD is not listed.
