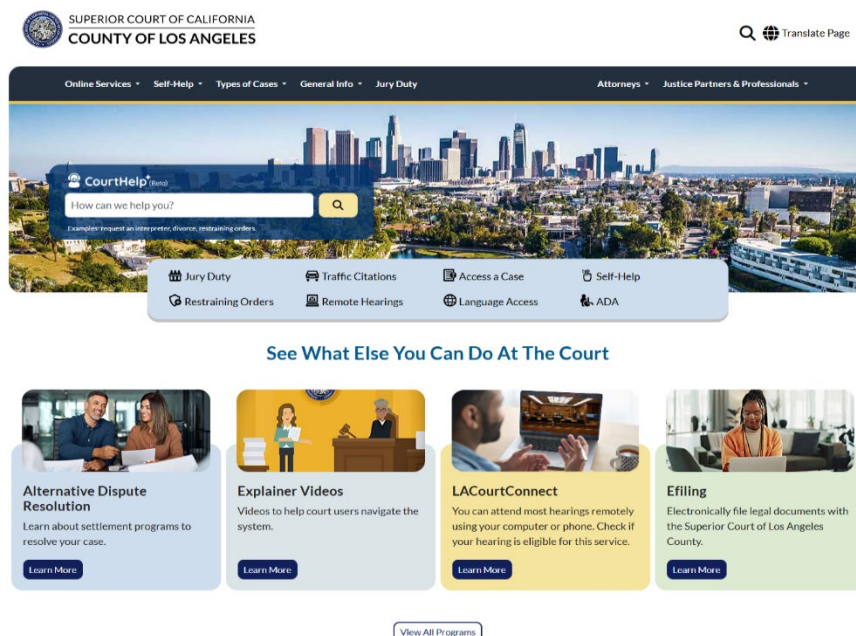
## SUPERIOR COURT OF LOS ANGELES COUNTY ANNOUNCES OFFICIAL LAUNCH OF NEW, COMPLETELY REDESIGNED, USER- CENTRIC WEBSITE

**New Website Is Now Live at [www.LACourt.ca.gov](http://www.LACourt.ca.gov), Featuring Major Usability Enhancements and a Modern, User-Focused Design**

The Superior Court of Los Angeles County has officially unveiled its newly redesigned, user-focused website at [www.LACourt.ca.gov](http://www.LACourt.ca.gov), Presiding Judge Sergio C. Tapia II announced today.

After nearly two years of planning, design and development, [www.LACourt.ca.gov](http://www.LACourt.ca.gov) presents a modern digital experience that reflects the Court’s ongoing commitment to improving access to justice with a new digital platform to serve the public, litigants and the legal community.

“The launch of the Court’s new website represents a major milestone in the Court’s mission to meet the needs of court users wherever they are,” Presiding Judge Tapia said. “We are proud of the hard work and dedication that went into this effort. The new design puts the user first, whether accessing the site from a phone, tablet or desktop. It is now easier than ever to find important information and services.”

The new website officially replaces the Court’s legacy site at [www.LACourt.org](http://www.LACourt.org). Users who visit the old website address will automatically be redirected to [www.LACourt.ca.gov](http://www.LACourt.ca.gov). The move to a “.ca.gov” website address enhances trust, transparency and alignment with statewide digital standards used by most California government entities.

“The Court is incredibly proud of the collective effort and dedication that went into the complete aesthetic, usability, and content redesign of our website,” Executive Officer/Clerk of Court David W. Slayton said. “The achievement reflects the hard work and collaboration and commitment of everyone involved. This new website includes important user-centric improvements designed to make court information and services more easily accessible.”

Some of the key features of the Court’s new website include:

- A streamlined homepage with quick links to commonly used resources and features.
- A mobile-responsive layout that improves usability across all device types.

- An interactive "CourtHelp" tool offering tailored responses to frequently asked questions.
- Improved translation options, powered by Google Translate, to better serve diverse communities.

The launch of [www.LACourt.ca.gov](http://www.LACourt.ca.gov) marks a significant step forward in the Court’s broader effort to modernize its services and better meet the expectations of court users through thoughtful innovation. With an average of 2.1 million monthly visitors, the Court’s website is among the most visited public-facing judicial resources in the country.

“Over 1,500 pages of content were carefully reviewed and restructured,” Slayton said. “Our goal was to make the Court more accessible, intuitive and user-friendly for all, from attorneys and justice partners to members of the public. We will continue to use technology to serve our community better and to ensure that justice is readily accessible to everyone across different devices and platforms.”
